Tender documents along with all supporting documents as mentioned in the checklist and the security deposit in shape of Demand Draft (DD) in favour of Executive Officer, NAC, Gopalpur should reach **NAC Office, Gopalpur through speed post/registered post/courier only** on or before **30.05.2025 till 02.00 PM.**
5. Any ALF/ WSHG/organization / individual, who has availed any Sairat lease earlier and have failed to abide by any terms & conditions or those who have not paid all dues to the NAC in previous Sairat leases shall not be eligible to participate in this bid competition.
